CUSTOMS (LIST OF PROHIBITED AND RESTRICTED IMPORTS AND EXPORTS) ORDER, 2009

The Minister in exercise of the powers conferred on him by section 90 of the *Customs Act*, makes the following Order:

1. This Order may be cited as the Customs (List of Prohibited and Restricted Imports and Exports) Order, 2009.

2. (1) The goods set out in Part I of the *First Schedule* are First prohibited imports within the meaning of section 89(1) of the *Customs Act*, Schedule. Cap. 66.

(2) The goods set out in Part II of the *First Schedule* are restricted imports within the meaning of section 89(1) of the *Customs Act*, and may, Cap. 66. subject to the conditions stipulated with respect to such goods, be imported.

3. (1) The goods set out in Part I of the *Second Schedule* are prohibited exports within the meaning of section 89(2) of the *Customs* Schedule. Cap. 66.

(2) The goods set out in Part II of the *Second Schedule* are restricted exports within the meaning of section 89(2) of the *Customs Act*, _{Cap. 66}. and may, subject to the conditions stipulated with respect to the exportation of such goods, be exported.

4. The prohibitions and restrictions on the goods set out in the *First* and *Second Schedules* that are imposed pursuant to section 89 of the *Customs Act*, shall apply to the goods concerned, irrespective of Cap. 66.

(a) how the goods are packaged; or

(b) whether the goods are combined with other goods which are neither prohibited nor restricted.

First5. (1) No person shall import any of the goods set out in the FirstSchedule.Schedule to this Order except that person is authorised to do so by a licenceCap. 329.issued, in respect of the goods, by the Minister under the Miscellaneous
Controls Act.

Second (2) No person shall export any of the goods set out in the Second Schedule. (2) No person shall export any of the goods set out in the Second Schedule to this Order except that person is authorised to do so by a licence issued, in respect of the goods, by the Minister under the Miscellaneous Controls Act.

6. A licence that was issued in respect of any of the goods under

1963. Order, 1962, prior to the commencement of this Order shall continue to be in effect for a period of 6 months from the date of the commencement of this Order.

RESTRICTED IMPORTS

(Section 89(1))

Arms etc. 1. Arms and ammunition, except under licence issued by the Minister Cap. 179. under the *Firearms Act*.

Cannabis 2. *Cannabis sativa* (known as Indian hemp or bhang), cannabis indica, sativa, etc. choras, or any preparation or mixture thereof, except under a licence issued by the Chief Medical Officer.

Imitation 3. Goods which bear a design in imitation of any currency or bank notes or coin in common use in Barbados or elsewhere unless with the approval of the Comptroller.

Spirits, etc.
4. Spirits (not being liqueurs, cordials, perfumed spirits or medicinal spirits) and wine, unless specifically reported as such, and unless in aircraft, or in ships of 20 tons burden at least, and in casks and other vessels capable of containing liquids, each of such casks or other vessels being the size or content of 9 gallons at the least or unless in glass or stone bottles properly packed in cases, or in demijohns, each case or demijohn containing not less than one gallon.

5. Tobacco, cigars, cigarillos or cigarettes, unless specifically reported as Tobacco. cigars, etc. such and unless in aircraft, or in ships of 20 tons burden at least, and unless in whole and complete packages each containing not less than 20 pounds net weight of tobacco, cigars, cigarillos or cigarettes, except that less than 20 pounds may be imported by Parcel Post.

Tobacco extracts, essences or other concentrations of tobacco, or any 6. Tobacco extracts, admixture thereof, tobacco stalks and tobacco stalk flour except under such etc. condition as the Comptroller, with the approval of the Minister, acting in his discretion may either generally or in any particular case allow.

All goods which if sold would be liable to forfeiture under the Trade 7. Goods Marks Act, and also all goods of foreign manufacture bearing any name or trade mark or purporting to be the name or trade mark of any manufacturer, dealer, or trader in Barbados or the United Kingdom or any British possession, unless the trade name or trade mark is accompanied by a definite indication of the country in which the goods were made or produced.

8. Goods bearing the Royal Arms of Great Britain or arms so closely Royal Arms. resembling the same as to be calculated to deceive unless the manufacturer of those goods holds Her Majesty's authority to use them in connection with his trade, business, calling or profession.

Goods imported as ship's or aircraft's stores except such as are Ships or aircraft required for consumption or use by or for the ship or aircraft, its officers, crew and stores. passengers.

Substances or chemicals within tariff heading number Ex 29.03 namely 10. halons, carbontetrachloride, methyl chloroform, hydrobromofluorocarbons and bromochloromethane, including any derivative or mixture thereof, that is capable of depleting the ozone layer.

Ozone depleting substances or chemicals.

Substances of chemicals within tariff heading number Ex 38.24 11. Refrigerant blends. constituting refrigerant blends that are capable of depleting the ozone layer.

Ozone 1. Substances or chemicals within tariff heading number Ex 29.03 namely chlorofluorcarbons, hydrochlorofluorocarbons and methyl bromide, including any derivative or mixture thereof, which is capable of depleting the ozone layer.

Refrigerant 2. Substances or chemicals within tariff heading number Ex 38.24 blends. constituting refrigerant blends which are capable of depleting the ozone layer.

General. 3. Goods the exporation of which is restricted by any other law of Barbados, except in accordance with that law.
