An Act to amend the *Customs Act*, Cap. 66 to revise the provisions of the Act with respect to the submission and receipt of advance passenger information and to provide for other related matters.

[Commencement: by Proclamation]

ENACTED by the Parliament of Barbados as follows:

#### Short title

**1.** This Act may be cited as the *Customs (Amendment) Act*, 2019.

## Amendment of section 2 of Cap. 66

- 2. Section 2 of the Customs Act, Cap. 66, in this Act referred to as the principal Act, is amended by inserting in the appropriate alphabetical order the following definitions:
  - "airline designator" means a code assigned to an airline by the International Air Transport Association or the International Civil Aviation Organisation;
  - "advance passenger information" means the information in respect of a passenger, crew member or other person transported in an aircraft or a ship;
  - "CARICOM" means the Caribbean Community established by the Treaty;
  - "code share information" means an arrangement between 2 or more airlines to publish and market a flight under
    - (a) a flight number; and
    - (b) an airline designator,
    - of the airlines as part of the timetable or schedule of the airlines;
  - "IMPACS" means the CARICOM Implementing Agency for Crime and Security established under the *Agreement Establishing the CARICOM Implementation Agency for Crime and Security*, 2006;
  - "intelligence agency" means a law enforcement agency which is established to share information and intelligence and to

- collaborate and cooperate with any other law enforcement agency on matters of mutual interest;
- "JRCC" means the Joint Regional Communication Centre which is a sub-agency of IMPACS which receives advance passenger information data and advance cargo information data;
- "participating country" means any country which enters into an agreement with JRCC to share advance passenger information data or advance cargo information data;
- "PNR" means passenger name record;
- "split or divided PNR information" means the division of PNR where one or more passenger is moved from an existing reservation on an aircraft or a ship and is given a new reservation on an aircraft or a ship;
- "Treaty" means the *Revised Treaty of Chaguaramas Establishing the* Caribbean Community, including the CARICOM Single Market and Economy, that was signed in the Bahamas on 5<sup>th</sup> July, 2001;
- "watch list" means a list which is compiled by an intelligence agency and which is used to watch or track the activities of criminals, criminal deportees and other persons of interest;".

# Amendment of section 34 of Cap. 66

- 3. Section 34 of the principal Act is amended by
  - (a) inserting immediately after subsection (3) the following:
    - "(3A) The master of every ship and the commander of every aircraft or the agent of the master or commander of the ship or aircraft, respectively, shall, at such time as is provided in subsection (4), provide the Chief Operations Officer of JRRCwith the data set out in Part I of

the *First Schedule* in an electronic format or in the form of a report that is approved by the Chief Operations Officer."; and

# (b) deleting subsection (4) and substituting the following:

- "(4) Where a ship or an aircraft is expected to arrive in Barbados, the data referred to in subsections (3) and (3A) shall be provided in the case of
  - (a) a commercial aircraft, no later than 40 minutes prior to the departure from the last port of call;
  - (b) a private aircraft, no later than 40 minutes prior to the departure from the last port of call;
  - (c) a ship arriving from outside the domestic space, no later than 24 hours prior to arrival; and
  - (d) a ship arriving from a destination within the domestic space, no later than one hour prior to arrival.".

# Repeal and replacement of section 34A of Cap. 66

4. The principal Act is amended by deleting section 34A and substituting the following:

# "JRCC to share advance passenger information with intelligence agencies

**34A.** Where data is provided to the Chief Operations Officer of JRCC pursuant to section 34(3A), the Chief Operations Officer shall share that information with intelligence agencies.".

## Insertion of sections 34A.1 and 34A.2 into Cap. 66

5. The principal Act is amended by inserting immediately after section 34A the following as section 34A.1 and section 34A.2:

# "Use of advance passenger information by JRCC

- **34A.1.**(1) Where the Chief Operations Officer of JRCC receives data pursuant to section 34(3A), JRCC shall use the advance passenger information to conduct screening of persons who are on board a ship or an aircraft, which enters, departs from or travels within the domestic space.
- (2) JRCC shall use the advance passenger information referred to in subsection (1) to conduct screening of persons against a watch list for the purposes of assisting participating countries or intelligence agencies in the furtherance of national, regional and international security.
- (3) Where JRCC conducts screening of persons pursuant to subsection (2) and as a result of the screening suspects that a person on board a ship or an aircraft is
  - (a) a criminal;
  - (b) a criminal deportee;
  - (c) involved in criminal activity; or
  - (d) a person of interest to an intelligence agency,

JRCC shall share the information with law enforcement agencies of participating countries and with intelligence agencies.

## Waiver

## **34A.2.**(1) The Minister may by order

- (a) waive any requirements of subsection (2), (3) or (3A) of section 34;
- (b) modify any of the data referred to in the First Schedule; or
- (c) waive or modify any of the requirements of subsection (4) of section 34 with regard to the time required for the submission of data.
- (2) An order made under subsection (1) is subject to negative resolution.".

# Amendment of the First Schedule to Cap. 66

- 6. The First Schedule to the principal Act is amended by
  - (a) deleting the words "34A(1)(b)" wherever they appear and substituting the words "34A.2(1)(b)"; and
  - (b) inserting immediately after paragraph B of Part I the following:
    - " C. Passenger Name Record Data as Available in a Ships's or an Aircraft's Reservation System

#### 1. PNR Locator

PNR locator.

## 2. Date of Reservation or Issue of Ticket

Date of reservation or issue of ticket for passenger.

## 3. Date(s) of Intended Travel

Date(s) of intended travel for passenger.

## 4. Surname and Given Name(s)

Family name and given name(s) of passenger.

## 5. Address and Contact Information

Address and contact information of passenger including telephone number(s) and e-mail address.

# 6. Information on Form of Payment for Ticket

Information on form of payment for ticket of passenger including billing address.

# 7. Travel Itinerary

Complete travel itinerary of passenger.

# 8. Frequent Flyer Information

Frequent flyer information of passenger.

# 9. Travel Agency or Travel Agent

Travel agency or travel agent used to reserve ticket of passenger.

## 10. Travel Status of Passenger

Travel status of passenger including confirmations, check-in status and no show status.

## 11. Split or divided PNR Information

Split or divided PNR information.

# 12. Ticketing Information

Ticketing information for passenger including ticket number, date of issuance of ticket, one way tickets and automated ticket fare quotations.

## 13. **Seat Information**

Seat number and any other seat information for passenger.

# 14. Baggage Information

All baggage information for passenger.

## 15. Code Share Information

Where applicable, code share information for passenger.

## 16. Number and Names of Other Persons

Number and name(s) of person(s) travelling with passenger.

## 17. General Remarks

General remarks including all available information on unaccompanied minors under 18 years such as the name and gender of the minor, language spoken by the minor, name and contact details of guardian on departure and relationship to the minor, name and contact details of guardian on arrival and relationship to the minor and the departure and arrival agent.

## 18. Any Advance Passenger Information

Any advance passenger information data collected for passenger.

".

## 19. Historical Changes to the PNR

Any historical changes to the PNR listed at 1 to 18.

## Repeal and replacement of the Second Schedule to Cap. 66

7. The Second Schedule to the principal Act is deleted and the Second Schedule as set out in the Schedule to this Act is substituted.
