**DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION)  
(BARBADOS RALLY CLUB) (NO. 2) ORDER, 2013**

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Barbados Rally Club) (No. 2) Order, 2013*.
2. The Barbados Rally Club, a company registered under the *Companies Act*, Cap. 308, is exempt from the payment of stamp duty in the sum of \$15,815.44 and value added tax in the sum of \$962,695.35 in respect of the vehicles listed in the *Schedule* for the purposes of the 2013 Sol Rally Barbados Event held on 1<sup>st</sup> June, 2013 and 2<sup>nd</sup> June, 2013.
