## Duties, Taxes and Other Payments (Exemption) Act Cap. 67B

# DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION) (BARBADOS RALLY CLUB) ORDER, 2010

The Minister in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act,* makes the following Order:

- 1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Barbados Rally Club) Order, 2010.*
- 2. The Barbados Rally Club, a company continued under the *Companies Act* is exempt from the payment of stamp duty in the sum Cap. 308. of \$13 081.64, in respect of the importation of the motor vehicles listed in the *Schedule* for the purposes of the 2009 Sol Rally Schedule. Barbados Event which was held on the 24th May, 2009, 30th May, 2009 and 31st May, 2009 respectively.
