**DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION)  
(BARBADOS RALLY CLUB) ORDER, 2016**

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Barbados Rally Club) Order, 2016*.
2. The Barbados Rally Club, a company registered under the *Companies Act*, Cap. 308, is exempt from the payment of stamp duty in the sum of \$12,994.68 and value added tax in the sum of \$1,120,396.44 in respect of the vehicles listed in the Schedule for the purpose of the 2015 Sol Rally Barbados Event held from May 29th, 2015 to May 31st, 2015.
