#### Duties, Taxes and Other Payments (Exemption) Act

#### CAP. 67B

#### DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION) (EMERGENCY ROOM INC.) ORDER, 2015

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

**1.** This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Emergency Room Inc.) Order, 2015.* 

**2.** In this Order,

"Company" means Emergency Room Inc., a company incorporated under the *Companies Act*, Cap. 308;

"equipment" means the medical equipment specified in the Schedule;

"project" means the layout and installation of equipment for the operation of the medical facility situated at Warrens Healthcare Complex, Warrens, St. Michael.

- 3. The Company is exempt from payment of
  - (a) withholding tax under the *Income Tax Act*, Cap. 73 for a period of 15 years with effect from 1<sup>st</sup> September, 2011
    - (i) on lease payments made by the Company to non-residents in respect of the lease of construction equipment used exclusively in the outfitting of the medical facility; and
    - (ii) on fees paid to non-residents for the provision of management and technical services to the Company, in connection with the layout

and installation of equipment for the operation of the medical facility; and

(b) corporation tax under the *Income Tax Act*, Cap. 73 on income accruing to the Company for a period of 15 years with effect from 1<sup>st</sup> September, 2011.

**4.**(1) The Company is granted one waiver of import duty on the importation of equipment specified in the *Schedule* to this Order where the equipment is required for the exclusive use of the project, and the Minister is satisfied on a certificate by the Project Manager that the equipment is so required.

(2) The duties and taxes payable in respect of the equipment to which subparagraph (1) refers, shall become payable where the equipment is sold or otherwise disposed of before the expiration of 3 years from the date of the importation of the equipment.

(3) Where equipment is imported free of duty, the Comptroller of Customs may require the Project Manager to

- (a) keep books and records in such form and containing such particulars as may be required by the Comptroller; and
- (b) permit the Comptroller or any person authorised by him in writing, at all reasonable times, to inspect such records and have access to any premises for the purpose of examining the equipment and satisfying himself of the accuracy of the particulars in relation to the contents in the records.

5. The concessions granted in this Order are granted on the condition that the project is completed by  $31^{st}$  December, 2011.
