DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION)
(INTERNATIONAL ONE METRE WORLD
CHAMPIONSHIPS) ORDER, 2010

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (International One Metre World Championships) Order, 2010*.

2. A person

(a) who was a competitor in the International One Metre World Championship held in Barbados from 20th June, 2009 to 27th June, 2009;

(b) who has been confirmed as a competitor in the championship by the host of the championship, Barbados Sailing Association Inc., a company incorporated under the *Companies Act*; and Cap. 308.

(c) whose name appears in the *Schedule*, Schedule.

is exempt from the payment of the fee prescribed for a citizen band model licence under the *Telecommunications (Licence Fees) Regulations, 2003*. S.I. 2003 No. 78.

3. This Order shall be deemed to have come into operation on the 8th May, 2009.
