2003/120.

Authority: These Regulations were made on 12th August, 2003 by the Minister under sections 5(2) and 32(1)(a) and (e) of the *Firearms Act*.

Commencement: 4th September, 2003.

1. These Regulations may be cited as the *Firearms (Licensing) (Forms and Fees) Regulations, 2003*.
