HIGHWAYS (ABANDONMENT) ORDER, 2002

- **1.** This Order may be cited as the *Highways (Abandonment) Order*, 2002.
- **2.** Farnell Alley, Parfitts Alley, Cavans Lane, Pierhead Lane and Wharf Road described in the *Schedule* to this Order are abandoned. Schedule.

SCHEDULE
