Authority: This Order was made on 26th October, 1983 by the Law Revision Commissioner under section 22A(3) and (4) of the *Law Revision Act*.

Commencement: 27th October, 1983.

1. This Order may be cited as the *Law Revision (Rectification of Omissions) Order, 1983*.

2. For the purposes of this Order, "revised edition" means the edition of subsidiary legislation published in 3 volumes and brought into force on the 1st August, 1983.

3. It is hereby declared

(a) that the enactments specified in the Schedule state the law in force on the 31st December, 1978, and that those enactments continued in force immediately before the 1st August, 1983;

(b) that the enactments so specified have been omitted from the revised edition; and

(c) that in accordance with section 22B of the *Law Revision Act*, those enactments shall be deemed to have remained in force as part of the laws of Barbados as from 1st August, 1983, notwithstanding the provisions of section 12(2) of the Act.
