**LAW REVISION ORDER, 2007**

The Law Revision Commissioner, in exercise of the powers conferred on him by section 15 of the *Law Revision Act*, makes the following Order with the approval of the Governor-General:

1. This Order may be cited as the *Law Revision Order, 2007*, and is referred to on the pages comprised in the Laws, pursuant to paragraphs 4 and 6 of this Order respectively as "L.R.O. 2003" and "L.R.O. 2007". Citation.
  
2. In this Order, the expression "the Laws" means the Laws of Barbados. Interpretation.
