POLICE (MISCELLANEOUS FEES) REGULATIONS, 2012

The Commissioner, in exercise of the powers conferred on him by section 79(1)(k) of the *Police Act*, with the approval of the Minister, makes the following Regulations:

1. These Regulations may be cited as the *Police (Miscellaneous Fees) Regulations, 2012*.
2. The fees payable in respect of a service rendered by a member of the force are specified in the *Schedule*.
3. The fees specified in the *Schedule* in respect of the services of a ballistic or handwriting expert rendered by a member of the Force shall be disbursed as follows:
 - (a) two-thirds of the fee is to be paid to the member; and
 - (b) the remaining of one-third shall be paid into the Consolidated Fund by the Commissioner.
4. The Commissioner may require all fees payable in respect of the services referred to in regulation 2 to be paid in advance into the office of the Commissioner by the person requesting those services.
5. The *Police (Miscellaneous Fees) Regulations* (S.I. 1984 No. 72) are hereby revoked.
