**2017–1**

An Act to amend the *Profession, Trade and Business Registration Act*, Cap. 373 to make provision for a reduction in the fees and licences related to certain professions, trades and businesses.

[Commencement: 1st January, 2017]

ENACTED by the Parliament of Barbados as follows:

**Short title**

1. This Act may be cited as the *Profession, Trade and Business Registration (Amendment) Act, 2017*.

**Amendment of section 2 of Cap. 373**

2. *Section 2 of the Profession, Trade and Business Registration Act, Cap. 373, in this Act referred to as the principal Act, is amended by deleting the definitions of “annual registration fee” and “first registration fee” and substituting the following in the appropriate alphabetical order:*

“ “annual registration fee” means the fee specified in the *Fourth Schedule* that is payable annually with respect to any profession, trade, business or calling mentioned in the *First, Second* or *Third Schedule*;

“first registration fee” means the fee specified in the *Fourth Schedule* which is payable on first registration with respect to any profession, trade, business or calling mentioned in the *First, Second* or *Third Schedule*;

**Amendment of section 3 of Cap. 373**

3. *Section 3 of the principal Act is amended in subsection (2) by deleting the words “the second column of”.*

**Amendment of section 4 of Cap. 373**

4. *Section 4 of the principal Act is amended in subsection (1) by deleting the words “the third column of”.*

**Amendment of section 5A of Cap. 373**

5. *The principal Act is amended by deleting section 5A and substituting the following:*

**“Temporary registration.**

**5A.** A person who is entitled to be temporarily registered in accordance with an enactment specified in Part III of the *First Schedule* shall pay to the Registrar at the time of registration, the fee for the relevant period as specified in the *Fifth Schedule*.”

**Repeal and replacement of the *Fourth and Fifth Schedules* to Cap. 373**

**6.** *The Fourth and Fifth Schedules to the principal Act are deleted and the Fourth and Fifth Schedules set out in the Schedule to this Act are substituted.*

**Commencement**

**7.** This Act shall be deemed to take effect from the 1<sup>st</sup> day of January, 2017.
