# Road Traffic Act Cap. 295

### ROAD TRAFFIC (AMENDMENT) REGULATIONS, 2009

The Minister in exercise of the powers conferred on him by section 124 of the *Road Traffic Act*, makes the following Regulations:

- 1. These Regulations may be cited as the Road Traffic (Amendment) Regulations, 2009.
- **2.** The *Road Traffic Regulations*, in these Regulations referred s.t. 1984/ to as the principal Regulations, are amended by deleting regulation 77 and substituting the following:

"Display of notices.

77. (1) Every owner of a hackney carriage, taxi or maxi-taxi shall cause to be displayed in a prominent position inside the hackney carriage, taxi or maxi-taxi a notice referred to as a tariff card containing

- (a) a statement of the prescribed fares as set out in Part I of the Second Schedule and printed on a suitable card in legible letters and figures in such colour as to be clearly distinguishable from the colour of the background whereon the letters are printed;
- (b) the registered number of the hackney carriage, taxi or maxi-taxi;
- (c) a notice containing the name and licence number of the driver for the time being in charge of the hackney carriage, taxi or maxi-taxi; and
- (d) a passport size photograph of the driver.

- (2) Every tariff card required to be displayed by paragraph (1) shall be fixed in such a position and manner inside the hackney carriage, taxi or maxi-taxi as to be at all times distinctly visible and legible to any person being conveyed in the hackney carriage, taxi or maxi-taxi.
- (3) Every owner of a hackney carriage, taxi or maxitaxi shall as the occasion requires renew the tariff card referred to in paragraph (1) on payment of the prescribed fee.
- (4) No owner nor driver of a hackney carriage, taxi or maxi-taxi shall wilfully or negligently cause or allow the tariff card to be inverted, detached in any manner or by any means to be concealed from the view of any person being conveyed in the hackney carriage, taxi or maxi-taxi at any time while the hackney carriage, taxi or maxi-taxi is plying or being used for hire.
- (5) Any person who contravenes this regulation is guilty of an offence.".

**3.** The principal Regulations are amended by inserting as Part IA of the Second Schedule, the First Schedule as set out in the *Schedule* to these Regulations.

4. Paragraphs 4, 5 and 6 of the Table of Fees for Examination appearing in Part I of the Fifth Schedule to the principal Regulations, are revoked and the paragraphs contained in Part I of the Second Schedule as set out in the *Schedule* to these Regulations are substituted.
