**DIRECTIONS GIVEN BY THE CHIEF TECHNICAL
OFFICER WITH THE APPROVAL OF THE
MINISTER RESPONSIBLE FOR ROAD
TRAFFIC UNDER REGULATION 88
OF THE ROAD TRAFFIC
REGULATIONS, 1984**

1. These directions may be cited as the *Road Traffic (Barbados Rally Club "All Stage Rally") Directions, 2013*.

2. The following roads will be closed during the specified period:

On Sunday May 26, 2013

(a) Between the hours of 9.00 a.m. and 6.00 p.m. in the parish of Saint Lucy, the section of road known as Church Hall, proceeding in an easterly direction along Mount Gilboa and Mount Gay Roads proceeding in a southerly direction along Oxford Road and finishing at the junction of Luke Hill Road and Charles Duncan O'Neal Highway.

On Saturday June 1, 2013

(b) Between the hours of 9.15 a.m. and 8.00 p.m. in the parish of Saint Lucy, the section of road known as Luke Hill commencing from its junction with Charles Duncan O'Neal Highway proceeding in a north easterly direction along Oxford Road and proceeding in an easterly direction to its junction with Mount Gay Road and continuing towards the road known as Alexandra proceeding in a westerly direction along Cottage and Pickering Roads finishing at the junction of Pickering Road and Highway 1C.

- (c) Between the hours of 9.30 a.m. and 8.30 p.m. in the parish of Saint Peter, the section of Road known as French Village proceeding in an easterly and southerly direction on that section of road known as Orange Hill, proceeding in an easterly direction pass the Rock, proceeding along Four Hills Road and finishing at its junction with Indian Ground.
- (d) Between the hours of 10.00 a.m. and 7.00 p.m. in the parish of Saint Andrew, the section of road known as Upper Parks from its junction with Fruitful Hill proceeding in a northerly direction along Dark Hole Road, continuing along Bruce Vale Road proceeding in a westerly direction at its junction with Highway 2 and continuing in a southerly direction along Spring Vale Road and finishing at Chapman Village Road near its junction with Carrington Road.

On Sunday June 2, 2013

- (e) Between the hours of 7.15 a.m. and 4.45 p.m. in the parish of Saint John, the section of road known as Maçaroni Village starting at its junction with Todds Road, proceeding in an easterly direction on Highway 4 along Guinea Road, proceeding in a southerly direction along Cliff Road finishing at its junction with Featherbed Lane.
- (f) Between the hours of 7.30 a.m. and 7.00 p.m. in the parish of Saint Philip, the section of road known as Padmore Village at its junction with Sunbury Road proceeding in a north easterly direction along Padmore Village and Harrow Roads continuing in an easterly direction to its junction with Bushy Park Road proceeding through Fairfield and Sandlord Roads, proceeding in a northerly and then easterly direction along Golden Grove Road, proceeding in a north westerly direction, turning at the junction of Golden Grove and Sealy Hall finishing at the junction of Sealy Hall and Highway 5B.

- (g) Between the hours of 8.05 a.m. and 6.00 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Tappy Pond in a northerly direction from its junction with Highway 3B, along Claybury Road turning north at its junction with Redland Road and then proceeding in an easterly direction along Wilson Hill and turning north at the junction of Wilson Hill Road and continuing in a northerly direction along Easy Hall Road finishing at its junction with Bonwell Road.

3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
