DIRECTIONS GIVEN BY THE CHIEF TECHNICAL OFFICER WITH THE APPROVAL OF THE MINISTER RESPONSIBLE FOR ROAD TRAFFIC UNDER REGULATION 88 OF THE ROAD TRAFFIC REGULATIONS, 1984

- 1. These directions may be cited as the Road Traffic (Barbados Rally Club, "FLOW King of The Hill" and "Sol Rally Barbados"), Directions, 2016.
 - 2. The following roads will be closed during the specified period:

On Sunday May 29, 2016

(a) Between the hours of 8.30 a.m. and 4.30 p.m. in the parish of Saint Thomas, the section of road known as Hangman's Hill, commencing from the junction with Highway 2 (Hopewell), proceeding in a westerly direction on the said Hangman's Hill, continuing in a northerly direction on Dukes road, proceeding in an easterly direction on Lion Castle road and finishing at the junction with Lion Castle Polo Estate.

On Saturday June 4, 2016

(b) Between the hours of 9.00 a.m. and 6.00 p.m. in the parish of Saint Andrew, the section of road known as Haggatts road commencing from the junction with St. Simon's road, proceeding in a southerly direction along the said Haggatts road, continuing in a southerly direction along Cane Garden, Spring Vale and Bruce Vale roads, proceeding in a southerly direction on Chapman's Village road and finishing at the junction of Chapman's Village and Bloomsbury roads.

- (c) Between the hours of 9.30 a.m. and 10.00 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Vault road, proceeding in a westerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly direction on Fortress Hill, continuing in a southerly direction on Dukes Tenantry road, continuing in a southerly direction on Dukes Tenantry road, continuing in a southerly direction on Dukes road, proceeding in an easterly direction on Hangman's Hill and finishing at the junction of Hopewell (Highway 2) and Lewis Village roads.
- (d) Between the hours of 10.30 a.m. and 4.00 p.m. in the parish of Saint Lucy, the section of road known as Mount Poyer, commencing from the junction with Bright Hall and Greenidges roads, proceeding in a southerly direction on the said Mount Poyer road, continuing in an easterly direction on Harrises road, proceeding in a southerly direction on Spring Hall road, continuing in an easterly direction on Cottage road, proceeding in a southerly direction on Mount Gay and Oxford roads, and finishing at the junction of Oxford and Luke Hill roads.
- (e) Between the hours of 3.00 p.m. and 9.00 p.m. in the parish of Saint Peter, the section of road known as French Village road, commencing from the junction with Applegrove, proceeding in a south easterly and southerly direction on the said French Village road, continuing in a westerly direction on Orange Hill road, proceeding in a south easterly direction on Four Hill road and finishing at the junction of Four Hill and Indian Ground roads.

On Sunday June 5, 2016

- (f) Between the hours of 8.30 a.m. and 4.00 p.m. in the parishes of Saint George and Saint John, the section of road known as Mount road commencing from the junction with Byre road, proceeding in a northerly direction on the said Mount road, continuing in an easterly direction on Kendal and Woodland roads, proceeding in a northerly direction on Ashford road, continuing in a westerly direction on Cherry Grove road, proceeding in a northerly direction on Roebuck Street road and finishing at the junction with Pool road (Highway 3B).
- (g) Between the hours of 8.30 a.m. and 4.00 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Natty Brown Hill, commencing from the junction with Ashbury road, proceeding in a northerly direction on the said Natty Brown Hill, continuing in a northerly direction on Tappy Pond and Claybury roads, continuing in an easterly direction on the said Claybury road, proceeding in a northerly direction on Wilson Hill and Easy Hall roads, continuing in an easterly and southerly direction on the said Easy Hall road, proceeding in an easterly direction on Malvern road and finishing at the junction with Hothersal and Edey Village roads.
- (h) Between the hours of 9.00 a.m. and 5.00 p.m. in the parish of Saint Philip, the section of road known as Mapps road, commencing from the junction with Thicketts and Three Houses roads, proceeding in a southerly direction on the said Mapps road, continuing in a westerly direction on Fairfield road, proceeding in a north westerly and southerly direction on Harrow road and finishing at the junction of Harrow and Sunbury roads.

- **3.** Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.
- **4.** These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
