DIRECTIONS GIVEN BY THE CHIEF TECHNICAL OFFICER WITH THE APPROVAL OF THE MINISTER RESPONSIBLE FOR ROAD TRAFFIC UNDER REGULATION 88 OF THE ROAD TRAFFIC REGULATIONS, 1984

1. These directions may be cited as the *Road Traffic (Barbados Rally Club, "FLOW King of the Hill"* and "Sol Rally Barbados") Directions, 2017.

2. The following roads will be closed during the specified period:

On Sunday May 28, 2017

(a) Between the hours of 8.30 a.m. and 4.30 p.m. in the parish of Saint Thomas, the section of road known as Hangman's Hill, commencing from the junction with Highway 2 (Hopewell), proceeding in a westerly direction on the said Hangman's Hill, continuing in a northerly direction on Dukes road, proceeding in an easterly direction on Lion Castle road and finishing at the junction with Lion Castle Polo Estate.

On Friday June 2, 2017

(b) Between the hours of 9.00 p.m. and 1.00 a.m. in the parish of Saint Peter, the section of road known as Orange Hill road (Sailor Gully), commencing from the junction with Four Hill road, proceeding in an easterly direction on the said Orange Hill road, continuing in a northerly direction on Prospect road and Charles Duncan Oneal Highway (Welch Town), proceeding in a northerly direction on Castle and Gays roads and finishing at the junction of Mount road.

On Saturday June 3, 2017

- (c) Between the hours of 10.00 a.m. and 6.00 p.m. in the parish of Saint Lucy, the section of road known as Collins road, commencing from the junction with the Baltic road, proceeding in a westerly direction on the said Collins road, continuing in a north westerly direction on Alexandria and Cottage roads, proceeding in a northerly direction on Pickerings and Spring Hall roads, continuing in a westerly and northerly direction on Mount Poyer and Harris' roads and finishing at the junction with Bright Hall road.
- (d) Between the hours of 10.30 a.m. and 8.00 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Dunscombe road, proceeding in an easterly and southerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly and southerly direction on Fortress Hill, continuing in a southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Lewis Village road and Hangman's Hill and finishing at the junction of Hangman's Hill and Hopewell road.
- (e) Between the hours of 11.00 a.m. and 7.00 p.m. in the parishes of Saint Joseph, Saint Andrew and Saint Thomas, the section of road being the upper section of St. Sylvan's road (Dark Hole), proceeding in a northerly direction on the said St. Sylvan's road, continuing in a southerly direction on Bruce Vale, Cane Garden, Friendship, Spring Vale and Chapman's Village roads and finishing at the junction of Chapman's Village and Sturges roads.

On Sunday June 4, 2017

- (f) Between the hours of 9.00 a.m. and 4.00 p.m. in the parish of Saint Philip, the section of road known as Padmore Village commencing from its junction with Sunbury Road, proceeding in a north easterly direction along Padmore Village and Harrow Roads, continuing in an easterly direction to its junction with Bushy Park Road, proceeding through Fairfield and Sandlord Roads, continuing in a northerly and then easterly direction along Golden Grove Road, proceeding in a north westerly direction on the said Golden Grove road and finishing at the junction with Sealy Hall road.
- (g) Between the hours of 9.30 a.m. and 5.00 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Natty Brown Hill, commencing from the junction with Ashbury road, proceeding in a northerly direction on the said Natty Brown Hill, continuing in a northerly direction on Tappy Pond and Claybury roads, continuing in an easterly direction on the said Claybury road, proceeding in a northerly direction on Wilson Hill and Easy Hall roads, continuing in an easterly and southerly direction on the said Easy Hall road, proceeding in an easterly direction on Malvern road and finishing at the junction with Hothersal and Edey Village roads.
- (h) Between the hours of 10.00 a.m. and 5.00 p.m. in the parishes of Saint John and Saint George, the section of road known as Byre road, commencing from the junction with Mount road (Highway 4), proceeding in a northerly direction on the said Byre road, continuing in an easterly direction on Woodland road, proceeding in a northerly direction on Kendal road, continuing in an easterly direction on Guinea road, proceeding in a southerly direction on Cox Hill and Cliff road, continuing in a westerly and south westerly direction on Featherbed Lane and finishing at the junction with Halton road (Highway 4B).

3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
