**DIRECTIONS GIVEN BY THE CHIEF TECHNICAL
OFFICER WITH THE APPROVAL OF THE
MINISTER RESPONSIBLE FOR ROAD
TRAFFIC UNDER REGULATION 88
OF THE ROAD TRAFFIC
REGULATIONS, 1984**

1. These directions may be cited as the *Road Traffic (Barbados Rally Club, "FLOW King of the Hill" and "Sol Rally Barbados") Directions, 2019*.

2. The following roads will be closed during the specified period:

On Sunday May 26, 2019

(a) Between the hours of 9.30 a.m. and 5.00 p.m. in the parishes of Saint Philip and Saint John, the section of road known as Golden Grove road, commencing from the junction with St. Catherine and Sealy Hill roads, proceeding in a westerly direction on the said Golden Grove road, continuing in a north westerly direction on Mapps road, proceeding in a westerly direction on Thicketts road, continuing in a northerly direction on Thicketts/Supers road, proceeding in a westerly direction on Stewart Hill and finishing at the junction of Stewart Hill and Massiah Street.

On Friday May 31, 2019

(b) Between the hours of 5.30 a.m. and 11.00 p.m. in the parish of Saint Philip, the section of road known as Padmore Village commencing from its junction with Sunbury road, proceeding in a north easterly direction along Padmore Village and Harrow roads, continuing in an easterly direction to its junction with Bushy Park road.

On Saturday June 1, 2019

- (c) Between the hours of 9.45 a.m. and 5.00 p.m. in the parish of Saint Lucy, the section of road known as Mount Poyer, commencing from the junction with Bright Hall and Greenidges roads, proceeding in a southerly direction on the said Mount Poyer road, continuing in an easterly direction on Harris road, proceeding in a southerly direction on Spring Hall road, continuing in an easterly direction on Cottage road, proceeding in a southerly direction on Mount Gay and Oxford roads, and finishing at the junction of Oxford and Luke Hill roads.

- (d) Between the hours of 10.00 a.m. and 7.00 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Dunscombe road, proceeding in an easterly and southerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly and southerly direction on Fortress Hill, continuing in a southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Dukes road, continuing in an easterly direction on Lewis Village road and Hangman's Hill and finishing at the junction of Hangman's Hill and Hopewell road.

- (e) Between the hours of 10.00 a.m. and 6.00 p.m. in the parish of Saint Andrew, the section of road known as Haggatts road commencing from the junction with St. Simon's road, proceeding in a southerly direction along the said Haggatts road, continuing in a southerly direction along Cane Garden, Spring Vale and Bruce Vale roads, proceeding in a southerly direction on Chapman's Village road and finishing at the junction of Chapman's Village and Bloomsbury roads.

On Sunday June 2, 2019

- (f) Between the hours of 8.45 a.m. and 4.00 p.m. in the parishes of Saint Philip, Saint John and Saint George, the section of road known as Cox Hill/Cliff road, commencing from the junction with Cottage Vale road, proceeding in a northerly direction on the said Cox Hill/Cliff road, continuing in a westerly direction on Guinea road, proceeding in a south westerly direction on Kendal road, proceeding in a southerly direction on Woodland and Mount roads and finishing at the junction of Mount and Brighton roads.

- (g) Between the hours of 9.00 a.m. and 4.30 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Natty Brown Hill, commencing from the junction with Ashbury road, proceeding in a northerly direction on the said Natty Brown Hill, continuing in a northerly direction on Tappy Pond and Claybury roads, continuing in an easterly direction on the said Claybury road, proceeding in a northerly direction on Wilson Hill and Easy Hall roads, continuing in an easterly and southerly direction on the said Easy Hall road, proceeding in an easterly direction on Malvern road and finishing at the junction with Hothersal and Edey Village roads.

- (h) Between the hours of 9.00 a.m. and 5.00 p.m. in the parish of Saint John, the section of road known as Society road, commencing from its junction with Highway H (Society Hill), proceeding in a north westerly direction on the said Society road, continuing in a southerly direction on Ashford road, proceeding in a westerly direction on Cherry Grove road, continuing in a northerly and north westerly direction on Roebuck Street road and finishing at the junction of Roebuck Street road and Pool road (Highway 3B).

3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
