# DIRECTIONS GIVEN BY THE CHIEF TECHNICAL OFFICER WITH THE APPROVAL OF THE MINISTER RESPONSIBLE FOR ROAD TRAFFIC UNDER REGULATION 88 OF THE ROAD TRAFFIC REGULATIONS, 1984

- 1. These directions may be cited as the *Road Traffic (Barbados Rally Club, "Flow King of the Hill" and "Sol Rally Barbados") Directions, 2018.* 
  - 2. The following roads will be closed during the specified period:

# On Sunday May 27, 2018

(a) Between the hours of 8.30 a.m. and 4.30 p.m. in the parish of Saint Thomas, the section of road known as Hangman's Hill, commencing from the junction with Highway 2 (Hopewell), proceeding in a westerly direction on the said Hangman's Hill, continuing in a northerly direction on Dukes road, proceeding in an easterly direction on Lion Castle road and finishing at the junction with Lion Castle Polo Estate.

## On Saturday June 2, 2018

(b) Between the hours of 9.45 a.m. and 5.30 p.m. in the parish of Saint Andrew, the section of road known as Haggatts road commencing from the junction with St. Simon's road, proceeding in a southerly direction along the said Haggatts road, continuing in a southerly direction along Cane Garden, Spring Vale and Bruce Vale roads, proceeding in a southerly direction on Chapman's Village road and finishing at the junction of Chapman's Village and Bloomsbury roads.

- (c) Between the hours of 10.00 a.m. and 6.00 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Dunscombe road, proceeding in an easterly and southerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly and southerly direction on Fortress Hill, continuing in a southerly direction on Dunscombe road, proceeding in a north easterly and southerly direction on Dukes road, continuing in an easterly direction on Lewis Village road and Hangman's Hill and finishing at the junction of Hangman's Hill and Hopewell road.
- (d) Between the hours of 10.30 a.m. and 10.00 p.m. in the parish of Saint Peter, the section of road known as French Village road, commencing from the junction with Applegrove, proceeding in a south easterly and southerly direction on the said French Village road, continuing in a westerly direction on Orange Hill road, proceeding in a south easterly direction on Four Hill road and finishing at the junction of Four Hill and Indian Ground roads.
- (e) Between the hours of 5.30 p.m. and 10.00 p.m. in the parish of Saint Lucy, the section of road known as Church Hill road, commencing from the junction with Nesfield road, proceeding in an easterly direction on the said Church Hill road, continuing in an easterly direction on Mount Gay road, proceeding in a westerly direction on Cottage road and finishing at the junction Pickering road.

# On Sunday June 3, 2018

(f) Between the hours of 8.45 a.m. and 4.00 p.m. in the parish of Saint Philip, the section of road known as Mapps road, commencing from the junction with Thicketts and Three Houses roads, proceeding in a southerly direction on the said Mapps road, continuing in a westerly direction on Fairfield road, proceeding in a north westerly and southerly direction on Harrow road and finishing at the junction of Harrow and Sunbury roads.

- (g) Between the hours of 9.00 a.m. and 4.30 p.m. in the parishes of Saint John and Saint George, the section of road known as Cliff road, commencing from the junction with Featherbed Lane, proceeding in a northerly direction on the said Cliff road, continuing in a westerly direction on Guinea road, proceeding in a southerly direction on Kendal road and in a westerly direction on Woodland road, continuing in a northerly direction on Todds road, proceeding in a north westerly direction on the said Todds road, continuing in a westerly direction on Ellesmere road and finishing at the junction of Ellesmere and Macaroni Village roads.
- (h) Between the hours of 9.30 a.m. and 5.00 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Hothersal and Edge Cliff roads, commencing at the junction with Edey Village road, proceeding in a westerly direction on the said Hothersal and Edge Cliff roads, continuing in a westerly direction on Malvern and Easy Hall roads, proceeding in a southerly direction on Easy Hall and Wilson Village roads, continuing in a southerly and westerly direction on Claybury road, proceeding in a westerly direction on Claybury and Gutter roads and finishing at the junction with Andrews road.
- 3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

**4.** These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
