**DIRECTIONS GIVEN BY THE CHIEF TECHNICAL  
OFFICER WITH THE APPROVAL OF THE  
MINISTER RESPONSIBLE FOR ROAD  
TRAFFIC UNDER REGULATION 88  
OF THE ROAD TRAFFIC  
REGULATIONS, 1984**

1. These directions may be cited as the *Road Traffic (Barbados Rally Club, "Sol Rally Barbados") Directions, 2014*.
2. The following roads will be closed during the specified period:

**On Sunday May 25, 2014**

- (a) Between the hours of 9.00 a.m. and 4.30 p.m. in the parish of Saint Thomas, the section of road known as Hangman's Hill, commencing from the junction with Highway 2 (Hopewell), proceeding in a westerly direction on the said Hangman's Hill, continuing in a northerly direction on Dukes road, proceeding in an easterly direction on Lion Castle road and finishing at the junction with Lion Castle Polo Estate.

**On Saturday May 31, 2014**

- (b) Between the hours of 9.30 a.m. and 9.00 p.m. in the parish of Saint Peter, the section of road known as French Village road, commencing from the junction with Applegrove, proceeding in a south easterly and southerly direction on the said French Village road, continuing in a westerly direction on Orange Hill road, proceeding in a south easterly direction on Four Hill road and finishing at the junction of Four Hill and Indian Ground roads.

- (c) Between the hours of 10.00 a.m. and 9.30 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Dunscombe road, proceeding in an easterly and southerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly and southerly direction on Fortress Hill, continuing in a southerly direction on Dunscombe road, continuing in a north easterly and southerly direction on Dukes road, proceeding in an easterly direction on Lewis Village road and Hangman's Hill and finishing at the junction of Hangman's Hill and Hopewell roads.
- (d) Between the hours of 10.30 a.m. and 10.00 p.m. in the parishes of Saint Thomas and Saint Andrew, the section of road known as Chapman Village road, commencing from the junction with Sturges road, proceeding in a northerly direction on the said Chapman Village, Bruce Vale and Spring Vale roads, continuing in an easterly direction on Dark Hole road and finishing at the junction with Fruitful Hill and Upper Parks roads.

**On Sunday June 1, 2014**

- (e) Between the hours of 8.30 a.m. and 6.00 p.m. in the parish of Saint Philip, the section of road known as Harrow road, commencing at the junction with Sunbury road, proceeding in an easterly direction on the said Harrow road, continuing in an easterly and southerly direction on Bushy Park road to its junction with Congo road, proceeding in a northerly and westerly direction on Fairfield road, continuing in a northerly direction on Bushy Park road, continuing in an easterly direction on Gaskin road to the entrance of Bushy Park racing circuit.

- (f) Between the hours of 9.00 a.m. and 5.00 p.m. in the parishes of Saint John and Saint George, the section of road known as Cliff road, commencing at its junction with Featherbed Lane, proceeding in a northerly direction on the said Cliff road, continuing in a westerly direction on Guinea road, proceeding in a southerly direction on Kendal and Woodland roads, continuing in a northerly direction on Todds road and finishing at the junction of Todds and Macaroni Village roads.
  
- (g) Between the hours of 9.00 a.m. and 5.30 p.m. in the parishes of Saint John and Saint Joseph, the section of road known as Hothersal and Edge Cliff roads, commencing at the junction with Edey Village road, proceeding in a westerly direction on the said Hothersal and Edge Cliff roads, continuing in a westerly direction on Malvern and Easy Hall roads, proceeding in a southerly direction on Easy Hall and Wilson Village roads, continuing in a southerly and westerly direction on Claybury road, proceeding in a westerly direction on Claybury and Gutter roads and finishing at the junction with Andrews road.

3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
