DIRECTIONS GIVEN BY THE CHIEF TECHNICAL OFFICER WITH THE APPROVAL OF THE MINISTER RESPONSIBLE FOR ROAD TRAFFIC UNDER REGULATION 88 OF THE ROAD TRAFFIC REGULATIONS, 1984

- 1. These directions may be cited as the Road Traffic (Barbados Rally Club, "Sol Rally Barbados") Directions, 2015.
 - 2. The following roads will be closed during the specified period:

On Sunday May 24, 2015

(a) Between the hours of 8.30 a.m. and 4.30 p.m. in the parish of Saint Thomas, the section of road known as Hangman's Hill, commencing from the junction with Highway 2 (Hopewell), proceeding in a westerly direction on the said Hangman's Hill, continuing in a northerly direction on Dukes road, proceeding in an easterly direction on Lion Castle road and finishing at the junction with Lion Castle Polo Estate.

On Saturday May 30, 2015

(b) Between the hours of 9.30 a.m. and 9.00 p.m. in the parish of Saint Peter, the section of road known as French Village road, commencing from the junction with Applegrove, proceeding in a south easterly and southerly direction on the said French Village road, continuing in a westerly direction on Orange Hill road, proceeding in a south easterly direction on Four Hill road and finishing at the junction of Four Hill and Indian Ground roads.

- (c) Between the hours of 10.00 a.m. and 7.00 p.m. in the parish of Saint Andrew, the section of road known as Haggatts road, commencing from the junction with St. Simon's road, proceeding in a southerly direction along the said Haggatts road, continuing in a southerly direction along Cane Garden, Spring Vale and Bruce Vale roads, proceeding in a southerly direction on Chapman's Village road and finishing at the junction of Chapman's Village and Bloomsbury roads.
- (d) Between the hours of 10.00 a.m. and 9.30 p.m. in the parish of Saint Thomas, the section of road known as Canefield road, commencing from the junction with Vault road, proceeding in a westerly direction on the said Canefield road, continuing in a southerly direction on Dukes road, proceeding in a westerly direction on Dukes road, continuing in a north easterly direction on Dukes Tenantry road, continuing in a southerly direction on Dukes road, proceeding in an easterly direction on Hangman's Hill and finishing at the junction of Hopewell (Highway 2) and Lewis Village roads.

On Sunday May 31, 2015

(e) Between the hours of 8.30 a.m. and 4.00 p.m. in the parishes of Saint George and Saint John, the section of road known as Mount road, commencing from the junction with Byre road, proceeding in a northerly direction on the said Mount road, continuing in an easterly direction on Kendal and Woodland roads, proceeding in a northerly direction on Ashford road, continuing in a westerly direction on Cherry Grove road, proceeding in a northerly direction on Roebuck Street road and finishing at the junction with Pool road (Highway 3B).

- (f) Between the hours of 9.00 a.m. and 4.30 p.m. in the parishes of Saint John and Saint George, the section of road known as Malvern road, commencing at the junction with Edey Village road, proceeding in a westerly direction on the said Malvern road, continuing in a northerly direction on Venture road, proceeding in a westerly direction on Easy Hall road, continuing in a southerly direction on Easy Hall and Wilson Hill Village roads, proceeding in a westerly and southerly direction on Claybury road, continuing in a westerly and southerly direction on Redland road, proceeding in a westerly direction on Sweet Vale road and finishing at the junction with Butcher road.
- (g) Between the hours of 9.00 a.m. and 3.00 p.m. in the parish of Saint Thomas, the section of road known as Jack-in-the-box road, commencing from the junction with Proute road, proceeding in a northerly and westerly direction on the said Jack-in-the-Box, continuing in a southerly direction on Hopewell road, proceeding in a westerly direction on Hangman's Hill and Lewis Village roads, continuing in a northerly direction on Dukes road and finishing at the junction with Fortress Hill and Lion Castle roads.
- 3. Any person who contravenes these directions or fails to comply with the orders given by a member of the Royal Barbados Police Force in uniform commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
