TECHNICAL AND VOCATIONAL EDUCATION AND TRAINING COUNCIL (LOANS) REGULATIONS, 2001

2001/14.

Authority: These Regulations were made on 17th January, 2001 by the Council, with the approval of the Minister, under section 25 of the Technical and Vocational Education and Training Council Act.

Commencement: 1st February, 2001

- 1. These Regulations may be cited as the *Technical and Vocational* Short title. Education and Training Council (Loans) Regulations, 2001.
 - 2. In these Regulations

Interpretation

"contract of training" means a contract of training for the provision of technical or vocational education entered into pursuant to the Act;

"lending rate" means a rate of 6 per centum per annum;

"trainer" means an employer, association or training institution.

3. (1) A trainer that has entered into a contract of training with Criteria to the Council shall in respect of any trainee for whom that trainer seeks be satisfied by an financial assistance satisfy the Council that the trainee

applicant.

- (a) is a citizen or permanent resident of Barbados;
- (b) is at least 16 years of age;
- (c) is pursuing or has been selected by a trainer to pursue a programme of technical or vocational training
 - (i) in accordance with the provisions of the Act; and
 - (ii) in accordance with any schemes formulated or programmes provided in accordance with the Act.

(2) Where a trainer satisfies the Council that a trainee referred to in paragraph (1) meets the criteria set out in that paragraph, that trainer may apply for a loan in Form 1 of the *Schedule*.

4. An amount by way of a loan of not more than \$50 000 may be disbursed to a trainer.

Security for loans.

- 5. (1) Every advance by way of a loan under regulation 4, any interest thereon and all expenses incidental thereto shall be secured to the Council by a first change on such of the fixed assets of the trainer as the Council may deem fit, having regard to the amount of the loan.
- (2) Where a loan cannot be secured in the manner specified in paragraph (1), every trainer to whom a loan is made shall provide security by way of 2 sureties in such amount as the Council, with due regard to the amount of the loan, determines by way of
 - (a) a bank or accredited insurance company registered in Barbados; or
 - (b) satisfactory personal sureties.
 - (3) Every personal surety referred to in paragraph (2)(b) must
 - (a) be between the ages of 21 and 55 years of age at the time of signing the agreement;
 - (b) be a citizen of Barbados who is resident in Barbados;
 - (c) have an income of such amount per annum or such other financial resources as the Council considers appropriate; and

(d) swear an affidavit of surety in Form 2 of the Schedule.

Alteration by trainer.

6. (1) Where a loan is approved for a specified course of training to be provided by a trainer, no alteration in respect of that course of training shall be made by that trainer except with the prior written approval of the Council.

- (2) Where a trainer fails to comply with the requirements of paragraph (1), the Council may cancel the loan and demand the immediate and full repayment thereof in addition to any interest that has accumulated up to the date of cancellation of the loan.
- 7. (1) The interest on all loans shall be an amount calculated at Interest on the lending rate and shall accrue from the date of disbursement. and

repayment of loans.

- (2) The interest on all loans that are in arrears shall be an amount calculated at the lending rate and an additional amount calculated at the rate of one per cent per month on the principal.
- (3) All loans shall be repaid in equal monthly instalments over a period not exceeding 5 years, and repayments shall commence from the completion date specified in the contract of training.
