Tourism Development Act

CAP. 341

TOURISM DEVELOPMENT ORDER, 2014

The Minister, in exercise of the powers conferred on him by section 37 of the *Tourism Development Act*, makes the following Order:

1. This Order may be cited as the *Tourism Development Order*, 2014.

2. The *Tourism Development Act*, Cap. 341, is amended by deleting the Second Schedule thereto and substituting the Second Schedule as set out in the *Schedule* to this Order.
