TRAFFIC CONTROL (CHRIST CHURCH CARNIVAL) RULES, 2014

The Commissioner of Police, in exercise of the power conferred on him by section 23(2) of the *Police Act*, with the approval of the Minister, makes the following Rules:

- 1. These Rules may be cited as the *Traffic Control (Christ Church Carnival) Rules*, 2014.
- 2. In these Rules,
- "alternate emergency route" means an alternate route which commences at Oistins and proceeds along Thornbury Hill, Callenders, ABC Highway, in the parish of Christ Church, Wildey, Collymore Rock, Martindale's Road to the Queen Elizabeth Hospital, in the parish of Saint Michael;
- "band" means any group of persons organised as a costumed band by the Festival Committee and approved by the Minister responsible for Culture, Sports and Youth to participate in the Christ Church Carnival Parade;
- "emergency route" means an emergency route which commences at Oistins and proceeds along Welches Road, Maxwell Road, Top Rock Roundabout, Highway 7, in the parish of Christ Church, Bay Street, Jemmotts Lane, Martindale's Road to the Queen Elizabeth Hospital, in the parish of Saint Michael;

"emergency vehicle" means a vehicle used by

- (a) the Barbados Red Cross;
- (b) the Department of Emergency Management; or

- (c) an ambulance service;
- "Festival Committee" means the Crop Over Festival Committee of the Ministry responsible for Culture, Sports and Youth;
- "relevant date" means Monday, 9th June, 2014;
- "relevant period" means the period from 08:00 hours to 18:00 hours;
- "route" means a route that commences at Silver Sands and continues along Breedy's Land, Hopewell, Sayers Court, Enterprise, Oistins, Pegwell Church Hill, Gall Hill, Kingsland and Wotton Road, in the parish of Christ Church;
- "vehicle" has the meaning assigned to it by section 2 of the *Road Traffic Act*, Cap. 295.
- 3. On the relevant date, during the relevant period, bands may parade only along the route commencing at Silver Sands and proceeding along the route to Wotton Road, in the parish of Christ Church.
- 4. On the relevant date, during the relevant period,
 - (a) Breedy's Land Road;
 - (b) Church Hill from its junction with Pegwell Road to its junction with Gall Hill Road;
 - (c) Enterprise Road;
 - (d) Gall Hill from its junction with Church Hill Road to its junction with Water Street;
 - (e) Hopewell Road;
 - (f) Kingsland Road;
 - (g) Pegwell Road from its junction with Oistins Road to its junction with Church Hill Road;
 - (h) Sayers Court Road; and

(i) Silver Sands Road,

in the parish of Christ Church, shall be closed to all vehicular traffic except vehicles used in the Christ Church Carnival Parade and vehicles used by members of the Festival Committee.

- 5. On the relevant date, between 06:00 hours and 20:00 hours, no person shall drive along, park or allow a vehicle to remain stationary on the route.
- 6. On the relevant date, during the relevant period, no person shall park or allow a vehicle to remain stationary along the alternate route or the emergency route, except for the purpose of picking up or setting down passengers.
- 7. All drivers and riders of vehicles, pedestrians and riders or leaders of animals using any of the roads specified in paragraph 4 or any of the routes specified in paragraph 6 shall exercise caution and shall comply with any order given by a member of the Royal Barbados Police Force in uniform.
- 8. Any person who contravenes these Rules or fails to comply with any order given by a member of the Royal Barbados Police Force, in uniform, is guilty of any offence and is liable on summary conviction to a fine of \$500 or to imprisonment for a term of 3 months.

9. These Rules do not apply to vehicles used by the Royal Barbados Police Force, the Barbados Defence Force, the Barbados Fire Service or any emergency vehicle.
