TRAFFIC CONTROL (FORE DAY MORNING JUMP UP) RULES, 2013

The Commissioner of Police, in exercise of the power conferred on him by section 23(2) of the *Police Act*, with the approval of the Minister, makes the following Rules:

- 1. These Rules may be cited as the *Traffic Control (Fore Day Morning Jump Up) Rules*, 2013.
- 2. In these Rules,
- "alternate route" means an alternate emergency route which commences at Exmouth Gap and proceeds along Westbury Road, President Kennedy Drive, Fontabelle, Cheapside, Broad Street, Charles Duncan O'Neal Bridge, Fairchild Street, River Road and Martindale's Road to the Queen Elizabeth Hospital, in the parish of Saint Michael;
- "emergency route" means an emergency route that commences at Spring Garden Highway and proceeds along Exmouth Gap, Westbury Road, Passage Road, Country Road, Roebuck Street, Halls Road and Martindale's Road to the Queen Elizabeth Hospital, in the parish of Saint Michael;
- "emergency vehicle" means a vehicle used by
 - (a) the Barbados Red Cross;
 - (b) the Department of Emergency Management; or
 - (c) an ambulance service;

- "Festival Committee" means the Crop Over Festival Committee of the Ministry responsible for Culture, Sports and Youth;
- "relevant date" means Saturday, 3rd August, 2013;
- "relevant period" means the period from 01:30 hours to 07:00 hours;
- "route" means Hincks Street, Princess Alice Highway, Harbour Road, turn left at Holborn Circle onto the Spring Garden Highway and onto the Frank Worrell Roundabout in the parish of Saint Michael.
- "vehicle" has the meaning assigned to it by section 2 of the *Road Traffic Act*, Cap. 295.
- 3. On the relevant date, during the relevant period, a Fore Day Morning Jump Up will take place commencing at the Carlisle Car Park, the Barbados Tourism Investment Inc. Car Park and the Barbados Investment and Development Corporation Car Park, in the parish of Saint Michael, and will proceed along the route.
- 4. On the relevant date, during the relevant period, Spring Garden Highway from its junction with Holborn Circle to its junction with Frank Worrell Roundabout, in the parish of Saint Michael, shall be closed to all vehicular traffic except vehicles used by the Festival Committee.
- 5. On the relevant date, during the relevant period, no person shall park or allow a vehicle to remain stationary on the following roads, except for the purpose of picking up or setting down passengers:
 - (a) Black Rock Road, from its junction with University Drive to its junction with Eagle Hall;
 - (b) Brighton Road, from its junction with Black Rock Road to its junction with Spring Garden Highway;
 - (c) Deacons Farm Road from its junction with Deacons Road to its junction with Brighton Road;

- (d) Deacons Road; and
- (e) Westbury Road,

in the parish of Saint Michael.

- 6. On the relevant date, during the relevant period, Brighton Road from its junction with Spring Garden Highway to its junction with Black Rock Road, in the parish of Saint Michael, shall be a one-way street with traffic travelling in the direction of Black Rock Road.
- 7. On the relevant date, during the relevant period, no person shall park or allow a vehicle to remain stationary along the alternate route or the emergency route except for the purpose of picking up or setting down passengers.
- 8. All drivers and riders of vehicles, pedestrians and riders or leaders of animals using any of the roads specified in paragraphs 4, 5 and 6 or any routes specified in paragraph 7 shall exercise caution and shall comply with any order given by a member of the Royal Barbados Police Force in uniform.
- 9. Any person who contravenes these Rules or fails to comply with any order given by a member of the Royal Barbados Police Force in uniform commits an offence and is liable on summary conviction to a fine of \$500 or to imprisonment for a term of 3 months.
- 10. These Rules do not apply to vehicles used by the Royal Barbados Police Force, the Barbados Defence Force, the Barbados Fire Service or any emergency vehicle.
